#### STATEMENT OF CONCERN

Libraries today, both public and private, contend with change in an order of magnitude, and they do this in the face of declining budgets. There is no "tried and true" roadmap for libraries in the new digital age. This presents both opportunities and challenges for AMIGOS.

The challenge for AMIGOS is to attract members in an environment that is full of formal and informal networks. Moreover, AMIGOS must continue to identify services and resources that have great quality, appeal and utility while remaining budget friendly. AMIGOS has the potential to expand and strengthen networking opportunities for its members, affording library directors and staff with channels for conferring and problem solving through collaboration. These collaborations will hopefully result in meaningful relationships which will strengthen the AMIGOS network.
